Chairs, tables, or set-up assistance cannot be provided. You may drive in to unload and reload with a 10 minute vehicle limit. Parking is available near the festival site. **Once the festival begins no one will be allowed to drive in or out of the site**

FESTIVAL RULES

- Please check in with Chamber Representative prior to setting up.
- Set up is Friday, August 19th beginning at noon.
- Traffic Barricades may not be moved by exhibitors, only by Chamber Representatives.
- You may drive on site for set-up and tear-down **during non-festival hours**. Each exhibitor is limited to 10 minutes to unload or reload. Once the festival begins you may not drive any vehicle on the festival site.
- If you leave the Festival early for an emergency, or arrive late, you must carry your display in or out. No vehicles will be allowed on the premise.
- **NO VEHICLES ARE ALLOWED ON SITE DURING NORMAL FESTIVAL HOURS**. If you have a vendor that is participating with you and they arrive after the festival opens at 5pm Friday and 11am Saturday they will have to walk everything in. This is for safety and insurance reasons. No exceptions will be made.
- All exhibitor refuse must be deposited in large commercial dumpsters at the festival site. Do not fill trash barrels left out for consumer use. Please dispose of all refuse at end of each day.

***Booths must be open on Friday at 5:00 pm. You may be open between 5:00 – 11:00 on Friday ;
11:00 am – 11:00 pm on Saturday!
Your booth must be open both days!***
